PROGRAM SUMMARY

The Citizenship by investment program of Montenegro is officially announced on Oct 1, 2018 for foreign investors. The decision came into force on Jan 1 and will run until 31 December 2021 offering investment citizenship to 2000 foreign investors. This is one of the most long-awaited in the industry.

This scheme is a special investment programme based on a special decision published in the Official Gazette of Montenegro 34/10, 40/16 and 62/18.

REQUIREMENTS

The Citizenship by Investment Program requires a person to make a significant economic contribution to the country. In exchange, and subject to the application process and due diligence checks, the applicants and their families are granted full citizenship.

The main applicant must be:

- at least 18 years old
- meet the application requirements by making e a contribution of €100,000 to government fund and invest in the real estate from:
- ➤ € 250,000 in north of the country and central region except Podgorica

or

➤ € 450,000 in north of the country: coastal region and Podgorica

The applicant's spouse and children of any age (provided that they are financially dependant on the main applicant) can apply as dependants of the main applicant.

€ 450,000 Real state investment in south of the country

Government fee:

or

- EUR 15,000.00 for the applicant;
- EUR 10,000.00 for each family member, up to four members at maximum;

- EUR 50,000.00 for each additional family member.
